terrorism and cyberwarfare?

Greece is a country in the south-east of Europe, bordering the countries of Turkey, North Macedonia, Albania and Bulgaria. It is located at the crossroads of Europe, Asia, and Africa. We have access to the Aegean Sea and Mediterranean Sea, Greece has the longest coastline on the Mediterranean Basin, featuring thousands of islands. We have been members of the European Union since 1981 and OSCE participants since 1973. The nation's capital is Athens, the cradle of democracy, as well as its largest city. The total population is near 10.7 billion, of which 93% of them are christians. Greece is a unitary parliamentary republic governed by liberal-conservatrice political party New Democracy (ND), the president of the government is Katerina Sakellaropoulou (first woman to become president of the Hellenic Republic), and the current prime minister is Kryakos Mitsotakis.

Greece has been a country ruled by the Ottoman Empire for many centuries and has direct access to the Mediterranean Sea. It has been a threatened country by many national terrorism organizations such as SPF, Rubicon... The security, policy defence and legitimate interest for peace of Greece are delegated to the Hellenic National Defence General Staff (HNDFS). About jihadist terrorism, Greece is aware that it represents a major threat not only to national security, freedom and democracy of the countries in the European Union but also for all the muslims countriess that suffers it. We also have improved our protection of high value units. In addition, we control the sea lines of communication and increase the number of maritime inspections operations and counter-terrorism operations. For possible attacks made on land and in our cities, the Greek government has developed more systems of cybersecurity in our country and increased the security of potential targets such as museums, political and social places and monuments by multiplicating the number of cameras, security personal...By doing this, we minimise the risk of a terrorist attack enven before it happens.

A very important element in the fight against terrorism and cyberwarfare is working with international associations and countries to exchange information about terrorist associations or other criminal associations. Greece wants to improve international cooperation and sharing of information with the objective to combat terrorism and cyberwarfare. Our government agree with the OSCE in promoving a co-operative and co-ordinated approach to reject terrorism at all levels, including co-ordination between national authorities, co-operation between states, co-operation with relevant international organizations, and, when needed establishment of public-private partnerships between state authorities, the private sector, civil society and the media.

In conclusion, we are a country worried about the problems that the OSCE is suggesting. Greece is aware of importance of counter-terrorism and cyberwarfare in our age and has take measures in order to prevent and also eradicate it. The Greek government strongly believes that cooperation between all the countries of the European Union and OSCE members is necessary to preserve freedom, order and democracy in our nations.
